

Whigumstyx Website Network (WWN) and Client agree to the following:

A. Website Design Services

- **a.** Client agrees to pay WWN the amount of \$350 to design a network website on the website network operated by WWN and covers five hours of website design time (billed at \$70 per hour).
- **b.** This payment is to be paid in two parts. Each part will constitute 50% of the total.
 - i. An initial payment of \$175 is to be paid prior to the start of the website design work.
 - **ii.** The final payment of \$175 is to be paid at the end of the website design work. These payments are non-refundable.
- c. Once these payments have been completed, the Client has 7-days to register (if Client hasn't already done so) their network website for recurring monthly membership billing on www.whigumstyx.com. If the Client does not complete this registration within 7-days, their network website will become inactive on the network and inaccessible to the Client until registration is completed. Once registration has been completed, and the monthly billing cycle has been initiated, the website will again be made active on the network and accessible to the Client

B. Monthly Membership

- a. Our membership is billed monthly and the client can cancel at anytime. If the client decides to cancel, their website will become inactive on the network and will cease to be accessible to the Client.
- **b.** The Client understands that their website is a network site and is hosted by WWN. When the Client cancels their membership, they are also canceling their network website(s).
- **c.** Websites hosted on the network cannot be transferred to a new website. However, if the Client wishes, they can export their website content (pages, blog posts, categories, menus, etc...) into an XML file using the export tool in their WWN website dashboard. The Client can then import that file into a new website (as long as this new website is also built on the Wordpress platform). In this way, the Client will retain their content, however, they will not retain their website design.

C. Domain Names (URL)

- **a.** The network website domain name (or URL) will be in the following format:
 - i. <u>clientsite.whigumstyx.com</u> (where *clientsite* is the network name for Client's website).
- **b.** If the Client already owns a domain name and wants their network site to use this name, this option is available. The Client can point this domain name to their network website. Instructions for doing this can be found at www.whigumstyx.com.
